Subject: VALIDITY OF COLOR COPIES OF ORIGINAL DOCUMENTS

The purpose of this circular is to inform that on board of Panamanian Flagged Vessels, shall be valid for a period no longer than thirty (30) calendars day, counting from the issuing date of the respective documents, full color copy of the following documents, as evidence that the application is being processed, until the original documents are received onboard:

MARINE MERCHANT DOCUMENTS:

- Provisional / Permanent Navigational License,
- Provisional / Permanent Radio License,
- Certificate of Insurance or other financial security in respect of civil liability for bunker oil pollution damage (BCC),
- Minimum Safe Manning Certificate (MSMC),
- International Ship Security Certificate (ISSC),
- Continuous Synopsis Record (CSR),
- Exemption Certificates,
- Certificate of Insurance or other Financial Security in respect of Liability for the Death of and Personal Injury to Passengers (PAL),
- Certificate of Insurance or other Financial Security in respect of Liability for the Removal of Wrecks (WRC),

SEAFARER'S DOCUMENTS:

- Processing Certificate of Licenses / Rating / Endorsement, commonly called Transitory Certificate (CT).
- Courses Endorsement Certificate for Officers and Ratings.
- Certificate of Inspection of Crew Accommodation (CICA).
- Dispensation Letter.
- Exemption Certificate.
