# Subject: Panama circular on Validity of Color copies of Original Documents.

- Panama Maritime Authority has issued revised merchant marine circular MMC-313 providing information on validity of color copies of original documents.
- Color copy of following documents will be issued as evidence of application is being processed; until the original documents are received onboard. These copies are valid for a period no longer than thirty (30) calendar days from the issue date of the document.

### > <u>MARINE MERCHANT DOCUMENTS</u>:

- a. Provisional / Permanent Navigational License,
- b. Provisional / Permanent Radio License,
- c. Certificate of Insurance or other financial security in respect of civil liability for bunker oil pollution damage (BCC),
- d. Minimum Safe Manning Certificate (MSMC),
- e. International Ship Security Certificate (ISSC),
- f. Continuous Synopsis Record (CSR),
- g. Exemption Certificates,
- h. Certificate of Insurance or other Financial Security in respect of Liability for the Death of and Personal Injury to Passengers (PAL),
- i. Certificate of Insurance or other Financial Security in respect of Liability for the Removal of Wrecks (WRC),

### > <u>SEAFARER'S DOCUMENTS:</u>

- a. Processing Certificate of Licenses / Rating / Endorsement, commonly called Transitory Certificate (CT).
- b. Courses Endorsement Certificate for Officers and Ratings.
- c. Certificate of Inspection of Crew Accommodation (CICA).
- d. Dispensation Letter.
- e. Exemption Certificate.
