<u>Subject: IMMARBE Merchant Marine Notice MMN-19-006 Reg Port State</u> Control Analysis and Self-Inspection Program

- Belize Flag Administration with an aim to minimize the number of detentions of Belize flagged vessels has implemented a Self-Inspection Program vide Merchant Marine Notice MMN-19-006 (copy attached).
- As a part of Self-Inspection Program, the Administration has developed a checklist highlighting all necessary items in order to confirm compliance with international and national requirements.
- The checklist is to be used as an instrument to self-inspect Belize flagged vessels by its Masters allowing the prompt identification of deficiencies and their rectification prior to a Port State Control Inspection. It is also aimed to minimize the number of deficiencies found by a Port State Control Officer and to mitigate the possibility of vessel detention by a Port State Control (PSC)) Authority.
- The Self-Inspection Checklist must be submitted to Administration's Technical Department on **monthly basis** and within the first 5 days of each month except for those vessels identified with 7 or more PSC deficiencies.
- All vessels found with 7 or more PSC deficiencies will be included in a Performance Improvement Plan (PIP). These vessels will be required to submit the Self-Inspection Checklist **twice a month for a period of 90 days**. First submission is to be done during the first 5 days and the second on the 15th of each month.
- Self-Inspection Checklist as above, duly verified and confirmed by the Designated Person Ashore (DPA) is to be submitted to the Administration's Technical Department (Eng. Eduardo Simon (technicalofficer@immarbe.com), Mr. Anique Sabal (technicalofficer2@immarbe.com) and Ms. Sharon Escalante (techsupport@immarbe.com).
- Evidences of submission of the Self-Inspection Checklist will be verified during Annual Flag State Inspections and during surveys/ audits by surveyors of Recognized Organizations. Lack of evidence will be considered as a deficiency due to noncompliance with Flag State requirements.
