Subject: Oman Maritime Circular No. 04/2020 and Circular No. 06/2020 on COVID-19 outbreak – Relaxation measures for ship's statutory certificates

1. The Maritime Administration of Oman vide attached Maritime Circular No. 04/2020 & Circular No. 06/2020 has adopted following relaxation measures with respect to the ship and seafarers documents as an exceptional measures in view of outbreak of COVID-19 pandemic.
 - a. The validity of following seafarers documents issued by the Administration or under the authority of the Administration, that has expired or will expire in coming months **are extended until 30th June 2020:**
 - i. Certificate of Competency;
 - ii. Certificate of Proficiency;
 - iii. Seafarer's Medical Fitness Certificate;
 - iv. Recognition Endorsement;
 - v. Recognition Documents (For service in Domestic Voyages); and
 - vi. Seafarer's Identification Document.
 - b. If the validity of a ship's statutory certificates has expired or is due to expire before 30 June 2020 and it is not possible to carry out survey or inspection of the ship due to limitations related to COVID-19, ship owner to apply to the relevant Recognized Organization, who have been authorized to extend the validity of statutory certificates, terms of scheduled surveys and/or inspections, for **up to three (3) months** without any additional approval of the Administration.
2. Ship owners/ operators and masters of Oman flagged ships are advised to be guided by above.

CIRCULAR RELATING TO CERTIFICATION OF SHIPS AND SEAFARERS FOR CORONAVIRUS (COVID-19) PANDEMIC.

The spread of the coronavirus has placed the entire world in an unprecedented situation. To slow the spread of the disease and mitigate its impacts, travel is being curtailed and borders are being closed. Transport hubs are being affected. Ports are being closed and ships denied entry.

The actions taken worldwide as a result of the outbreak pose a serious challenge for administrations to allow the continued training of seafarers, revalidate certificates, including medical certificates and issuance of endorsements attesting recognition of certificates in accordance with the International Convention on Standards of Training, Certification and Watchkeeping for seafarers (STCW Convention), 1978, as amended.

The prevailing situation would have direct affect on the following aspects of the shipping community.

- (a) the continued training of seafarers, revalidation of certificates, including medical certificates, and issuance of endorsements attesting recognition of certificates in accordance with the

International Convention on Standards of Training, Certification and Watchkeeping for seafarers (STCW Convention), 1978, as amended;

(b) Continuous Discharge Certificate (CDC) and Service period of Bangladeshi seafarers; and

(c) All matters related to ships surveys, inspections, certifications and/or renewal of statutory certificates;

(d) Lockdown, Curfew, Quarantine, Denial, Embarkation and Disembarkation, refusal, isolation measures imposed by various authorities is causing seafarers retention on board for unexpected period and the seafarers passport and other travel documents are expiring.

Considering the COVID-19 Pandemic situation Department of Shipping Bangladesh Promulgate following circular to the Bangladeshi shipping community.

2. Seafarer's Certification:

Certificates of Competency (CoC) and Certificates of Proficiency (CoP) which will be expired before 30th April 2020 will be granted a general extension till 30th June 2020. Seafarers will not be required to apply for the extension.

Consideration will be given to allow seafarers who hold foreign issued Certificates of Competencies (CoC) to continue serving onboard Bangladesh Registered Ships, if they are unable to revalidate their CoC before the expiry date due to the COVID-19 outbreak. Bangladesh Registered Ships owners and managers may submit such request in-writing to Department of Shipping (DoS), accompanied with a confirmation of continued validity from the issuing authority of the seafarer's CoC.

3. Minimum Safe Manning Document (MSMD)

Where it can be demonstrated that a crew member is required to depart a vessel owing to the COVID-19 and unable to be replaced, exemptions to MSMD will be considered on a case by case basis and should be supported by risk assessments from the company.

4. Medical certificate:

If a medical certificate expires whilst the seafarer is at sea, the certificate is allowed to remain in force until the next port of call where the seafarer can obtain a medical certificate from a qualified medical practitioner. This is permitted for up to 30th June 2020. If a seafarer is urgently required to join a ship with an expired medical certificate, the Department of Shipping (DoS) must be contacted to request permission.

5. Continues Discharge Certificate (CDC):

Continues Discharge Certificate (CDC) which will be expired before 30th April 2020 will be granted a general extension till 30th June 2020. Seafarers will not be required to apply for the extension.

6. Extension of Seafarers Employment Agreements (SEA):

The Seafarers Employment Agreements (SEA) should remain valid. The company should explain to the seafarers as to why they need to remain on board. If any of the SEA's have expired, they need to be extended or new ones issued. The company need to ensure that the seafarers are sent home at the first available opportunity. Evidence should be retained by both the seafarer and the Company clearly demonstrating the reason why the Seafarer was asked to extend their contract.

7. Extension of mandatory surveys, audits and expiry of statutory certificates:

Statutory certificates which will be expired before 30th April 2020 will be granted a general extension till 30th June 2020. Owners or operators of Bangladesh Registered ships will not required to apply for the extension.

8. Port State Control Measures:

Port State Control officers are instructed to take a pragmatic and practical approach in relation to these certificates and endorsement extensions and their acceptance in the excise of Port State Control procedures.

Due to the global pandemic devastating many countries of the world and its potential occurrence here in Samoa, the Ministry as the Maritime Administration, has decided for all Certificates of Competency (CoC) issued to Samoan seafarers on board local and foreign vessels expiring on or before 30 April 2020, are granted a general extension of up to three (3) months. This means, the individual seafarer will not be required to submit an application for revalidation.

The above general extension may be reviewed from time to time as necessary and appropriate.

Taking into account difficult epidemiologic situation in various regions of the world due to the COVID-19 outbreak and pursuant to the measures undertaken by the Supreme Committee to mitigate the outbreak in order to protect the health of seafarers and employees of the maritime sector, from one side and, to ensure the uninterrupted operation of ships flying the Omani Flag, from the other side, this Administration has adopted following relaxation measures regarding the ships and seafarers documents.

مع مراعاة الوضع الوبائي الصعب في مناطق مختلفة من العالم بسبب تفشي كوفيد-١٩ وعملاً بالتدابير التي اتخذتها اللجنة العليا للتخفيف من تفشي المرض من أجل حماية صحة البحارة وموظفي القطاع البحري من جانب، ولضمان التشغيل المتواصل للسفن التي ترفع العلم العماني ، من الجانب الآخر، اعتمدت هذه الإدارة إجراءات التخفيف الآتية فيما يتعلق بوثائق السفن والبحارة.

If the validity of a ship's statutory certificates has expired or is due to expire before 30 June 2020 and it is not possible to carry out survey or inspection of the ship due to limitations related to COVID-19, shipowner should apply to the relevant recognized organization, that are hereby authorized, in each particular case, without additional approval by this Administration, to extend the validity of statutory certificates, terms of scheduled surveys and/or inspections, for to up to three (3) months.

إذا كانت صلاحية الشهادات القانونية للسفينة قد انتهت أو من المقرر أن تنتهي قبل ٣٠ يونيو ٢٠٢٠ ، ولا يمكن إجراء مسح أو فحص للسفينة بسبب القيود المتعلقة بكوفيد-١٩، يجب على مالك السفينة تقديم طلب إلى هيئة التصنيف المعترف بها ذات الصلة المخولة بموجبه ، في كل حالة على حده ، دون موافقة إضافية من هذه الإدارة ، لتمديد صلاحية الشهادات القانونية وشروط المسوحات و / أو عمليات التفتيش المجدولة ، لمدة تصل إلى ثلاثة (٣) أشهر.
