# Subject: Maldives Marine Circular No: INT-2020/001 Reg Extension of Expiry dates of CoC and Trading Certificates due to COVID-19 outbreak

 Maldives Maritime Administration has issued Circular No. INT-2020/001 providing instructions with regards to extension of expiry dates of Seafarers Certificates and trading certificates issued to Maldivian flagged vessels as outlined below due to outbreak of COVID-19 pandemic.

#### a. Extension of the validity of Seafarers Certification:

- i. Certificate of Competency (CoCs) expiring on or after 01<sup>st</sup> March 2020 will be extended for **six** (6) **months** from the date of expiry of the certificate on seafarer's application.
- ii. Mandatory short courses required for the revalidation of CoC will also be **extended for six (6) months** on seafarer's application.
- iii. Medical Fitness certificates expiring on or after 01<sup>st</sup> March 2020 are extended until 30<sup>th</sup> June 2020.

#### b. Extension of the validity of Trading Certificates:

i. Trading certificates issued to Maldivian flagged vessels expiring on or after 01<sup>st</sup> March 2020 are extended **until 30<sup>th</sup> June 2020.** 

#### c. Extension of Port Facility Permits:

- i. Port Facility Permits expiring on or after 01st March 2020 are extended until 30th June 2020.
- 2. Ship owners/ operators and masters of Maldivian flagged ships are advised to be guided by above.

Subject: Extension of Expiry dates of CoC and trading certificates issued to Maldivian flag Vessels

Reference: IMO Circular Letter no. 4204/Add.5 (17-03-2020) & Maldives Transport Authority Announcement NO: (IUL)202-M/1/2020/40 (30-03-2020)

In light of the current control measures put in place by the government of the Maldives on 12<sup>th</sup> March 2020 under the Public Health Emergency Law to prevent the spread of Covid–19 and following the guidelines of IMO Circular Letter no. 4204/Add.5 dated 17 March 2020, Shipowners, Operators, Charterers, Shipping agents, Seafarers and all concerned parties are hereby notified of the following:

- Certificate of Competencies expiring on or after 01<sup>st</sup> March 2020 may apply for an extension of 6 months from the date of expiry of the certificate. Seafarers applying from overseas may apply for extension through our email: <a href="mailto:maritime@transport.gov.mv">maritime@transport.gov.mv</a>.
- Mandatory short courses required for the revalidation of CoC will also be extended for 6 months by application and can be made via our email: maritime@transport.gov.mv.
- Medical Fitness Certificates expiring on or after 01st March 2020 are hereby extended until 30th June 2020.
- Trading certificates issued to Maldivian flag vessels expiring on or after 01st March 2020 are hereby extended until 30th June 2020.
- Port Facility Permits expiring on or after 01st March 2020 are hereby extended until 30th June 2020.
