Sub: Implementation of the Maritime Labour Convention, 2006-the inspection and certification of the maritime labour conditions of Indian flag ships-reg.

Director General of Shipping, Govt has vide, Merchant Shipping Notice No. 16 of 2016 laid down its procedure for obtaining Maritime Labour certificate under the Merchant shipping (Maritime Labour Rules), 2016 and regulation 5.1.3 of MLC, 2006. On receipt of a request for clarification on the clause C of Para 9 of the Annexure-1 of the said MS notice, the said Para is amended and may be read as under;

“Recreation facilities including but not limited to television, showing of films, magazine, sports equipments, internet & e-mail facilities, Library etc., shall be provided on board ships at no cost to seafarers. The seafarers shall be provided reasonable access to ship to shore telephone communications, where available, with any charge for use of the service, being reasonable in amount”.

2. This issues with the approval of the Director General of Shipping & Additional Secretary to the Govt. of India.
