## To Whomsoever it may concern

## <u>Subject: Belize – Carriage of printed colour copies for original flag State</u> documents.

- International Merchant Marine Registry of Belize (IMMARBE) has issued Circular Letter No. IMM/GOB 001/17 (copy attached) providing the Administration's requirements wrt the carriage of printed colour copies for original flag state documents onboard ships.
- The Administration requires that all original documents must be carried on board Belize Flagged vessels. However, in cases when the original documents, as mentioned below, are en-route to the vessel, a grace period of thirty (30) days is granted from the date of issuance of the certificates. During this period, printed colour copies of such documents must be carried on board as evidence of compliance / certification.
- Following is the list of documents (but may not be limited to) for which printed colour copies as mentioned above is acceptable.
  - ➤ Provisional or Permanent Patent of Navigation;
  - ➤ Provisional or Permanent Ship Radio License;
  - ➤ Certificate of Insurance or other Financial Security in Respect of Civil Liability for Oil Pollution Damage (CLC);
  - ➤ Certificate of Insurance or other Financial Security in Respect of Civil Liability for Bunker Oil Pollution Damage (BCC);
  - ➤ Certificate of Insurance or other Financial Security in Respect of Liability for the Removal of Wrecks (WRC);
  - ➤ Certificate of Insurance or other Financial Security in Respect of Liability for the Death of and Personal Injury to Passengers (PAL);
  - ➤ Minimum Safe Manning Certificate (MSMC);
  - Continuous Synopsis Record (CSR);

- ➤ Exemption Certificates, Waiver of Requirements, Equivalent of Arrangements, Attestation Letters;

- ➤ Certificate of Receipt Application for Officers (CRA);
- > Endorsement Certificate for Officers.
- During the thirty (30) day period stated above, the colour copy of the documents will have the same validity as the original documents.
- Ship Owners / managers and Masters of Belize flagged vessels are advised to be guided by above.
