# HAZARD IDENTIFICATION (HAZID)


Hazard identification is a technique for the identification of all significant hazards associated with the particular activity under consideration.


### QUANTITATIVE RISK ASSESSMENT (QRA)

QRA combines the hypothetical hazardous events and its frequency of occurrence to understand risk exposure to people and environment in terms of individual risk (IR) and societal risk (FN curve).

### **CONSEQUENCE ANALYSIS**

Consequence modeling involves quantification of the probability of accidental toxic, fire and explosion events and their consequences. For toxic releases, effects on people are evaluated.







# HAZARD AND OPERABILITY STUDY (HAZOP)

HAZOP is a systematic approach to identify hazards and operability problems occurring as a result of deviations from the intended range of process conditions.


### **SAFETY INTEGRITY LEVEL (SIL)**

SIL is a measurement of performance required for a safety instrumented function (SIF) or probability of failure on demand (PFD) for a SIF.
