## Subject: DGS M.S.Notice No. 02 of 2021 Reg. - Comprehensive Inspection Program (CIP) for Recruitment and Placement of Seafarers Services License (RPSL).

- Reference is made to Technical Circular No. 136/2020/Amended, dated 03<sup>rd</sup> December 2020 regarding enforcement of a Comprehensive Inspection Program (CIP) for RPS License holders with effect from 01<sup>st</sup> April 2021.
- 2. The Directorate General of Shipping, GOI vide Merchant Shipping Notice No. 02 of 2021, dated 31<sup>st</sup> March 2021 has now informed that the effective date of implementation of CIP for RPSL as stated above **is deferred for a period of one month**.
